In 1992 Selene Webb (née Mills) founded Cambridge Early Music and its annual summer schools in Renaissance and Baroque music. Since their foundation, the summer schools have flourished and hundreds of amateur and aspiring professional musicians have benefited from them.



Cambridge Early Music Summer Schools are unique in the UK Early Music Calendar and to encourage young musicians to continue to take part, Nick Webb (Selene's husband) has set up the Selene Webb (née Mills) Memorial Bursary Fund. The summer schools cost around £60,000 to run and the full cost of a place is about £855 per person. For many young people this is a large amount to find.
